funds received including \$50,000 loan. We are looking at the funds exceeding \$17,000
as a surplus. We still need to pay back the \$50,000 loan

Grain Elevator costs - \$4,400, do we keep it or save the money to fix it. Katherine is asking for funding and we will hold off for response. If we can't find money somewhere else, we will need to think about not keeping it. It costs \$2,000 to remove it. Look into a doubling grant. Decisions needed by the end of the month.
